## 2016 APPLE CROP UPDATE

**Michigan** – The Michigan Processing Apple Growers Marketing Committee met on Monday, December 5 and reevaluated the 2016 apple crop. The committee revised their earlier estimate of 26 million bushels to 28 million bushels. There was a very small amount of fruit left behind because of lack of boxes and/or lack of an outlet. Many growers have stated less desirable processing varieties will most likely be removed over the winter. Overall, growers were very optimistic

**New York** – The apple crop was re-estimated to be in the mid to upper 20 million bushel range. Hot temperatures and drought conditions caused fruit to be small. Fruit condition also suffered as growers delayed harvest due to undersize fruit. Fresh movement has been good and most storages were filled.

**Pennsylvania** – The apple crop picked out 20-25% shorter than estimate. Excessive hail, heat and drought in July and August contributed to the shortfall. The extreme weather conditions included 3 1/2" of rain over the first weekend in October.

**Virginia & North Carolina** – Some blocks of fruit picked out shorter than expected and quality was off. Fruit size was smaller than anticipated due to heat, drought and cell division. Some growers experienced labor shortages at the beginning of harvest.

**Washington** – The crop has been estimated to be 137 million bushels for fresh with a total crop estimate of 175-180 million bushels. For the most part, harvest was finished mid-November. Juice prices had weakened considerably to \$2-3.00/cwt. Juice prices were expected to remain low through spring because of cheap foreign apple juice concentrate prices.

According to the US Apple Market News, as of December 1, fresh apple holdings were reported at 120.3 million bushels which was 13% greater than a year ago. Total processing holdings were 42.9 million bushels which was 1% more than a year ago.

## **WORKER PROTECTION STANDARDS (WPS) OUTREACH SESSIONS**

The Federal Worker Protection Standards protects ag workers and pesticide handlers by reducing the risks of injury or illness resulting from contact with pesticides on farms and in forests, nurseries and greenhouse.

In a joint effort between MDARD, MSU, and Michigan Farm Bureau, outreach sessions are scheduled to inform growers of the new requirements. The sessions are scheduled for:
